

Draft Plan Notable Goals

- Revitalize Glen Cove Avenue through zoning changes and pedestrian experience improvements
- Consider zoning updates for the North Shore Country Club (study required), including a conservation subdivision with open space preservation
- Improve crosswalks, street safety and connections
- Consider zoning changes in residential areas with smaller lots to make life easier for property owners (study required)
- Encourage more housing options, especially for young professionals and senior population
- Protect water supply and quality
- Maintain the historic and unique character of the Village, including the creative community
- Protect natural resources and promote sustainability efforts
- Mitigate coastal issues (flooding, erosion) with resilience and climate adaptation measures
- Reduce stormwater runoff
